
In this regard, it is submitted that distribution of additional 65 LMT capacity to various States was done on the basis of distribution of buffer in proportion of NFSA allocation. This exercise was done in June'2021 (Calculation sheet is enclosed as Annexure-A). It is submitted that CAP capacity was also taken as available capacity while deciding storage gap. However, it has now been decided to phase out CAP capacity. Keeping this in view, revised distribution has been done by excluding CAP capacity and revised calculation sheet is enclosed as Annexure-B. Change in distribution of 65 LMT capacity to various States considering availability of covered capacity only is as follows:

It may be seen that allocation of capacity is coming out to be higher in case of UP & Rajasthan. Further, in case of Rajasthan, variation is minor. As such, we may keep allocation

of capacity to various States as per earlier proposal except UP where capacity allocation may be made 18.5 LMT instead of 17 LMT. The locations for allocating additional 1.5 LMT in UP may be done on the basis of recommendation of SLC as per procedure & location may be finalized in second phase of silo construction.


