Sir/ Madam.

Please refer FCI Headquarters communication on the subject cited above. It was requested to prepare Custom Bid documents in consultation with local GeM representative as per the requirements of storage space in the Region and float warehousing tender through GeM portal.

As informed during MPR meeting, certain inputs were received from CWC regarding the terms and conditions of the tender floated on GeM. A meeting was held at FCI HQrs under the chairmanship of CMD with MD CWC wherein the issues were deliberated and decisions were taken. In accordance with the decisions, necessary modifications have been made in the MTF. A copy of revised MTF is enclosed.

It is further informed that godowns of CWC/SWC already with FCI, having central pool stocks, shall continue to be rehired under the present system of rate determination by the Ministry on cost plus basis. The new capacity including from CWC/SWC shall be hired through open tender on GeM on market discovered rates.

Therefore, it is advised that the tender floated through GeM portal, may be scrapped and 'Custom Bid' may be prepared as per the revised MTF and location wise tenders may be floated as per the requirements of storage space in the Region.

Accordingly, CWC and SWCs may also be requested to participate in the tender for offering their new capacities. It is also requested to make efforts to ensure that maximum potential bidders get themselves on-Board/ Registered with GeM and participate in these tenders.

In case of any type of difficulties in the tendering process, local GeM representative may be contacted.
