Sir/ Madam.

Please refer the FCI Headquarters letter dated 22.05.2021 and discussions held during MPR Meeting dated 21.05.2021 on the subject cited above.

As directed by the Ministry, FCI shall float tenders on GeM for hiring of godown through Custom bidding within a week wherein CWC shall also participate. GeM will assign Business Development Assistant to assist FCI with the 'Custom bidding' project.

The matter has been discussed with GeM and an indicative document for hiring of warehouses has been attempted by FCI Headquarters in accordance with the provisions of PWS tender documents and in consultation with GeM representatives.

It is therefore, requested to prepare Custom Bid documents in consultation with local GeM representative as per the requirements of storage space in the Region and float warehousing tender through GeM portal latest by 28.05.2021. CWC and SWCs may also be requested to participate in the tender and offer their warehouses. It is also requested to make efforts to ensure that maximum potential bidders get themselves on-Board/ Registered with GeM and participate in these tenders.
