Sir/Madam,

- 1. This is regarding Storage charges payable to CWC for the year 2020-21. Ministry of CA,F&PD, Department of Food & Public Distribution, Govt. of India, New Delhi vide letter dated 10.05.2022 (Copy enclosed) has decided to fix the Storage Charges payable by FCI to CWC @ Rs. 4.96 per bag of **50 Kg per month** w.e.f. 1^{st} April, 2020 for the year 2020-21 at the actual storage capacity (before re-assessment, as decided during fixation of storage charges related to FY 2019-20).
- 2. As per the aforementioned letter, these rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storages for a minimum period of one year or more. Ministry vide letter dated 14.02.2022 has also clarified that actual storage capacity applies to capacity before reassessment.
- 3. As regards, non-guaranteed charges, the existing policy will follow till further orders.
