

Ministry of CA,F&PD, Department of Food & Public Distribution, Govt. of India, New Delhi vide letter 6-21/2019-SG-I dated 22.10.2020 has decided to fix the storage Charges payable by FCI to CWC @ Rs 5.39 per bag of 50 Kg per month w.e.f. 1st April,2018 for the year 2018-19 at the actual Storage Capacity. These rates shall be applicable in those cases where the FCI agrees to keep the stocks for guaranteed storage for a minimum period of one year or more. As regards, non-guaranteed charges, the existing policy will continue until further orders.

Further, it is also requested to extend the revised rates payable to CWC godowns @ Rs-5.39 per bag of 50 Kg per month w.e.f. 1st April, 2018 for the year 2018-19, to the godowns of all State Warehousing Corporations (SWCs) also.

In this regard, instructions issued by the Ministry vide their letter no 6-20/2015-SG-I dated 01.11.2016 and letter dated 01.11.2017 (Copies enclosed) and instructions issued by FCI Headquarters vide letter no S&C/QP/06/25/2019/Stg.-VII (214)/ dated 10.11.2020 (copy enclosed) regarding applicability of Storage Charges payable by FCI to SWC for the year 2017-18 may also be referred to for compliance please.

I am directed to refer to CWC's letter no. CWC-CD/II-FCI/Rate Revision/2018-19/235, dated 05/11/2019 on the subject mentioned above and to say that on the basis of recommendations of the Principal Advisor Cost, PI Cell of this Department, conveyed vide their OM No. 11011/02/2020-PI Cell, dated 20/01/2020, and concurrence of IFD vide their Note dated 29.09.2020, it has been decided to fix the storage charges payable by FCI to CWC @ Rs. 5.39 per bag of 50 kg per month w.e.f. 1st April 2018 for the year 2018-19 at the actual storage capacity. These rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storage for a minimum period of one year or more.
