विषय: Applicability of Storage Charges payable to SWC at par with CWC for the year 2019-20 -reg.

Sir/Madam,

Ministry of CA,F&PD, Department of Food & Public Distribution, Govt. of India, New Delhi vide letter dated 13.09.2021 (Copy enclosed) has decided to fix provisional rates of Storage Charges payable by FCI to CWC @ Rs. 4.93 per bag of 50 Kg per month w.e.f. 1st April, 2019 for the year 2019-20 at the actual storage capacity. These rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storage for a minimum period of one year or more.

As regards, non-guaranteed charges, the existing policy will follow till further orders.


Further, it is also requested to extend the revised rates payable to CWC godowns @ Rs.4.93 per bag of 50 Kg per month w.e.f. 1st April, 2019 for the year 2019-20 to the godowns of all State Warehousing Corporations (SWCs). In this regard, instructions issued by the Ministry vide their letter no. 6-20/2015-SG-I dated 01.11.2016 and letter dated 02.11.2017 (Copies enclosed).

It is further stated that the storage charges payable by FCI to CWC was @ Rs. 5.39 per bag of 50 Kg per month w.e.f. 1st April 2018 for the year 2018-19 and provisional rates of Storage Charges payable by FCI to CWC has been fixed @ Rs. 4.93 per bag of 50 Kg per month for the year 2019-20. Since, there is decrease in the payable storage charges @ Rs- 0.46 per bag of 50 Kg per months as compared to storage charges payable for FY 2018-19, all the field offices are requested to recover the excess storage charges paid to CWC/SWCs.



Subject: Revision of storage charges payable by FCI to CWC for the year 2019-20.

Sir

I am directed to refer to CWC's letter No. CWC/CO-CD/COST/4/2020-FCI Rate dated 18/09/2020, on the subject mentioned above and to say that on the basis of the recommendations of the Principal Advisor Cost, PI Cell of this Department, conveyed vide their OM No. 11011/13/2021-PI Cell dated 17/05/2021 and Finance Division's OM No. G-11013/11/2020-FD-II dated 13/08/2021, the provisional rates of storage charges payable by FCI to CWC will be fixed @ Rs. 4.93 per bag of 50 kg per month w.e.f. 1st April 2019 for the year 2019-20 at the actual storage capacity. These rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storage for a minimum period of one year or more.

2. As regards, non-guaranteed charges, the existing policy will follow till further orders.
3. Some issues raised by CWC & FCI have been taken up with the Ministry of Finance for their comments/ clarification. A decision on the final rates of storage charges will be taken by the Ministry in view of the comments/ clarifications received from the Ministry of Finance on those issues.
4. This issues with the concurrence of Integrated Finance Division of the Department and the approval of Hon'ble Minister of Consumer Affairs, Food & Public Distribution.




I am directed to refer to the above mentioned subject and to say that this Department vide its letter of even number dated 01.11.2016 (copy enclosed) has already clarified that storage charges payable by FCI to CWC is extended to the godowns of all State Warehousing Corporations (SWCs) where storage and preservation services are similar in comparison to that of CWC. This parity in Storage charges payable to CWC and SWCs is to be maintained till further orders, considering that SWCs are State Govt. Agencies with 50% shareholding by CWC.

2. Hence, it is once again clarified that for year 2013-14, 2014-15 and onwards till further orders rate payable for storage by FCI to CWC will be applicable to SWCs where storage and preservation services are similar to that of CWC.
