Sir/Madam,

1. This is regarding Storage charges payable to CWC for the year 2019-20. Earlier Ministry of CA,F&PD, Department of Food & Public Distribution, Govt. of India, New Delhi vide letter dated 13.09.2021 has decided to fix **provisional rates** of Storage Charges payable by FCI to CWC @ **Rs. 4.93 per bag of 50 Kg per month** w.e.f. 1st April, 2019 for the year 2019-20 at the actual storage capacity.
2. After considering the representation submitted by CWC, Ministry vide letter dated 02.02.2022 (**Copy enclosed**) has enhanced the Storage Charges payable from **Rs. 4.93 to 5.07 per bag of 50 Kg per month** w.e.f. 1st April, 2019 for the year 2019-20 at the actual storage capacity.
3. As per the aforementioned letter, these rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storages for a minimum period of one year or more. Ministry vide letter dated 14.02.2022 has also clarified that actual storage capacity applies to capacity before re-assessment.

4. As regards, non-guaranteed charges, the existing policy will follow till further orders.

It is also requested to extend the revised rates payable to CWC godowns to the godowns of all State Warehousing Corporations (SWCs). In this regard, instructions issued by the Ministry vide their letter no. 6-20/2015-SG-I dated 01.11.2016 and letter dated 02.11.2017 are once again enclosed.

Subject: Revision of Storage Charges payable by FCI to CWC for the year 2019-20.

Sir,

I am directed to refer to this Department letter of even no dated 13.09.2021 on the subject mentioned above and to say that the provisional Storage charges for the year 2019-20 have been re-examined in detail in PI Cell & integrated Finance Division, in pursuance of the issues highlighted by Central Warehouse Corporation and deliberated upon extensively in various meetings. The Provisional Storage Charges of the year 2019-20 have been proposed by PI Cell to be increased by Rs.0.14 per bag of 50 kg per month.

2. As such, on the basis of recommendations of the Principal Advisor Cost, PI Cell of this Department and concurrence of IFD vide their Note No. G-I1013/11/2020-FD-II dated 4.1.2022, it has been decided to fix the provisional storage charges payable by FCI to CWC @ Rs. 5.07 per bag of 50 kg per month w.e.f. 1st April 2019 for the year 2019-20 at the actual storage capacity. The final rates will be decided after consultation with the Ministry of Finance. These rates shall be applicable in those cases where the FCI agrees to keep the stock for guaranteed storage for a minimum period of one year or more.

3. As regards, non-guaranteed charges, the existing policy will continue until further orders.

4. This issues with the approval of Hon'ble Minister of Consumer Affairs, Food & Public Distribution.
