महोदय/महोदया,

Please refer to the instructions issued vide above references.

Instances have come to the notice of FCI Hqrs. wherein PEG godowns are being taken over on guarantee basis without completion of development work such as protective boundary / wire fencing, internal roads, etc. In this connection, attention is drawn towards clause No.31 of MTF wherein it is clearly stated that godown on guarantee basis is to be taken over after completion of godown in all respects. Further, detailed instructions regarding the check list for taking over part completed godowns on AUB have been issued vide this office letter dated 17.10.14 and it is only after completion of all the items that the godown is to be taken over on guarantee basis.

Further, it has also come to notice that different practices are being followed for payment of rent in godowns taken over on AUB basis. In this regard it is clarified that payment of rent for such godowns should be made only on pro rata basis for actual stock held in storage on day to day basis. Payment of extra rent, if any, needs to be recovered from future bills.

It is requested to again direct all the field offices for strict compliance of the instructions.
