Clarification with respect to capacity approved for State of Meghalaya and Subject:-Assam under PEG Scheme.

Sir,

I am directed to refer to FCI's letter no. E-Bh/(354)4-IV/Meghalaya2013/910 dated 27.02.22018 from DGM (S&C) and to say that this Department vide letter no 20.01.2009-FC-II dated 09.06.2016 (copy enclosed) approved the proposal for construction of godowns of 15,000 MT capacity in Meghalaya under PEG Scheme. However, a proposal of 40,000 MT or 27,500 MT for construction of godowns as mentioned in the above said letter was not approved by this Department as per record available.

- It may also be noted that this Department vide its letter no 20.01/2009-FC-II 2. dated 20.01.2017 approved the proposal for construction of godowns of 60,000 MT capacity in Assam under PEG Scheme, however, as per KPI dated 28.02.2018 sent vide email dated 06.04.2016 from GM (G&C), the approved capacity for State of Assam and Meghalaya is 110,000 MT and 40,000 MT respectively.
- It is, therefore, requested to clarify the approved capacity with respect to State Government of Meghalaya and Assam under PEG Scheme at the earliest.

2. However, with regard to the proposal for construction of godowns of 1,72,000 MT capacity. Assam it is seen that there is no deficiency in storage capacity after taking into account the balance quantity available in Plan Scheme (except capacity for which land is not yet available) and the capacity of silo sanctioned for Changsari (Assam). Hence, capacity creation under PEG Scheme is not approved.
