Sub: Cancellation of unsanctioned capacity under PEG Scheme – reg.

Sir,

Please refer to your office letter No. 20-1/2012-FC-II dated 20-08-2014 vide which approval for cancellation of 24,203 MT small and residual capacity that cannot be retendered, was accorded.

In this regard, it is informed that the above cancelled capacity includes 1,800 MT capacity at Bilaspur (Chhattisgarh) also. Further, SLC for Chhattisgarh in its meeting held on 13.05.2014 has recommended for construction of 28,340 MT capacity at following centres: -

Out of the above recommended capacity, 26,910 MT is to be adjusted from the total of small residual capacities that could not be constructed due to over estimation of capacity in each compartment of a godown by CGSWC and 1,430 MT (28,340 MT – 26,910 MT) out of 1,800 MT surrendered by CWC at Bilaspur. The matter was discussed in the 40<sup>th</sup> meeting of HLC held on 14.08.2014 and it was decided to accept the above proposal of SLC.

It is therefore requested to treat only 370 MT (1,800 MT – 1,430 MT) capacity as cancelled from Bilaspur centre, instead of 1,800 MT.

It is further informed that HLC in the same meeting has decided to delete a capacity of 1,08,600 MT from the target of PEG Scheme constructed by KSWC at various centres in Karnataka.
