महोदय,

As you are aware that under PEG Scheme investors are given a maximum period of one year for completion of construction in case of non-railway siding godown and two years in case of railway siding godown from date of acceptance letter. Delay in construction period upto one year is allowed on the request of an investor with corresponding reduction of guarantee period (Refer clause 31 of MTF). However, a number of projects have been completed beyond permisible time of two years (three years in case of railway siding godown) i.e. stipulated one year + extended one year and request has been made to utilize the same on guarantee basis. Also, in a number of cases extension have been sought beyond maximum permisible time for completion of the projects.

HLC in its 43rd meeting held on 25.05.2015 took note of the above mentioned cases and has advised that, SLC after detailed deliberation should recommend all such cases with its clear recommendations for consideration/decision of HLC.
