Deduction of TDS by FCI from the rental bills of godowns constructed under PEG Sub: Scheme.

Sir,

It has been reported by nodal agencies in Punjab & Haryana that some district offices in Punjab & Haryana are making dedeution of TDS @ 10% on the reimbursement of rentals as well as service charges from nodal agencies while making reimbursement of rental bills of godowns constructed under PEG Scheme. Nodal Agencies further deduct another 10% TDS before disbursing to private investors. As a result, investors who are entitled to get 90% of the rent after 10% TDS deduction, are getting only 81% due to double TDS deduction.

The issue has been examined in Hqrs in consultation with finance division which had also solicited the opinion of Tax Consultant and it is clarified that FCI will not make TDS deductions on reimbursement of rentals to nodal agencies for PEG godowns hired on lease and also lease with services. The reimbursement aspect will also be properly incorporated in the agreement between nodal agency and FCI. However, TDS will be deducted by FCi on supervision charges in case of lease only godowns and Supervision plus Services (PMS) charges in case of lease with services, payable to the nodal agency for which nodal agencies should produce a separate bill.

It is therefore requested to take necessary actions in this regard.
