Sir,

Kindly refer to above mentioned references on the cited subject. HLC in its 34<sup>th</sup> meeting on 20.05.2013 has decided to implement PEG scheme for a capacity of 3.19 lakh MT in NE states. Accordingly, SLC meetings in respect of Tripura and Mizoram were held on 10.07.2013. The SLC proposals for these two states were placed before HLC in its 35<sup>th</sup> meeting held on 24.07.2013 and it was decided by HLC to approve the proposals allowing both the states to go ahead with the tendering process.

Now, the minutes of SLC meetings held on 07.06.2013, 29.06.2013 and 11.07.2013 have been forwarded to this office in respect of Assam, Manipur and Meghalaya respectively. As proposal for implementation of PEG scheme in NE zone have already been approved in principle by HLC in its 35<sup>th</sup> meeting on 24.07.2013 and SLC proposals of Assam, Manipur & Meghalaya are merely regarding permission for going ahead with tendering process and nomination of FCI as nodal agency, the same need not be placed before HLC once again.

In view of above it has been decided that Assam, Manipur and Meghalaya regions in NE zone may go ahead with the tendering process. FCI may act as nodal agency in these states as proposed by SLC. Further, the issue of Nagaon in Assam region will be clarified separately after consulting Engineering Division.

It is therefore requested to take necessary action accordingly. This issues with the approval of competent authority.
