Sub: Modifications in MTF for PEG scheme in respect of non-DCP states and DCP states.

Sir/Madam,

It is to inform that HLC in its meeting on 24.07.2013 after detailed deliberations has made following decisions:

1. Amendment in the Clause 30 of MTF:-

The **Clause 30** of the MTF may be read as under:

“At places where there is full rake Railway goods shed, the site should preferably be within 8 KM of goods shed. Where no full rake railway goods shed exists the site should preferably be within a radius of 8 Kms. of the municipal limits of such places or 15 Kms. from zero point of such location. Wherever 25,000 MT and above capacity is required, it should preferably have the provision for private railway siding. The land should preferably be on National or State Highway. **They should offer only such land/site which has access through all-weather black topped or RCC/CC road of minimum width of 22 feet except in hilly regions. Brick paved road or gravel road is not acceptable.** The road leading to the godown should be free from any kind of traffic restriction for truck movement. Distance criteria of within 8 KMs. radius from full rake railways goods shed does not apply to godowns with a railway siding.”

The above amendment should be incorporated in the MTF to be issued in future with immediate effect.

2. **Condonation of delay in submission of required documents for land:**

In case there is delay in submission of required documents for land beyond permissible time period of 120 days, HLC has resolved to authorise SLCs to decide such matters on merit of each individual case.
