Sub: Private Sidings under FCI's Private Entrepreneurs Guarantee (PEG) Scheme 2008 & 2009.

In reference to the above mentioned scheme of FCI, dispensation has been done under the Liberalization of Siding Rules policy for the FCI godowns with Sidings developed under the PEG Scheme 2008 & 2009 under the conditions stipulated below :-

1. The Sidings shall only deal with food grain traffic of FCI. The commercial notification issued by the Zonal Railway will specify that the siding is working under the FCI PEG Scheme. Such sidings cannot be opened for any other commodity. Necessary checks in this regard to be built in FOIS by CRIS upon receiving the notification from Zonal Railway.
2. No co-user permission shall be given for such sidings.
3. The consignor/consignee of such food grain traffic for these sidings shall be FCI only.
4. E-payment of freight shall be made by FCI only.
5. After the stipulated period of contract with FCI, unless FCI extends the contract as per provision of PEG Scheme, the siding owner shall have the option to convert into a Private Freight Terminal (PFT) by paying the requisite fee, or it shall be closed down.
6. The above exemption may be permitted to only those sidings the tenders for which have been finalized by FCI prior to the date of issue of the letter from the Ministry of Railways based on the approval.
7. In case of misdeclaration of commodity/consignee or handling of any other commodity, penalty as per extant rules would be levied.

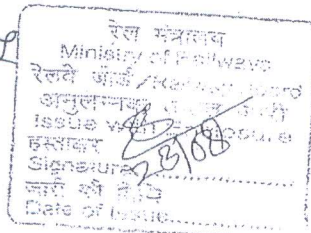
