Subj:- Rate of storage charges payable by FCI to CWC for the year 2002-03  
(w.e.f. 1.4.2002).

1. The revision of the rate of storage charges for the year 2002-03 payable by FCI to CWC for storing foodgrains in their godowns was under consideration of the Ministry of Consumer Affairs, Food & Public Distribution. As per the Ministry of Consumer Affairs, Food & Public Distribution letter No.6-21/2003-SG dated 27<sup>th</sup> July, 2004 (copy enclosed), it has been decided :

- (a) To fix the storage charges payable by FCI to CWC at the rate of Rs. 1.79 per bag of 50 kg. with effect from 1.4.2002 for the year 2002-03. These rates shall be applicable in those cases where the FCI agrees to keep the stock for a minimum period of one year or more.
- (b) However, where the utilization of space is not guaranteed by the FCI, the CWC may charge the storage charges and other related charges such as weighment charges, insurance charges etc. from the FCI at the same rates, as is being charged from the private parties depositing foodgrains with the CWC. This arrangement will be effective from 1.3.2004.
- (c) It has also been decided to increase the supervision charges from the existing 5% to 8% w.e.f. 1.4.2004 payable by the FCI to CWC.

2. FOR VARYING PERIOD THE RATE OF 50 KG. BAG @ RS. 1.79 (RUPEES ONE AND PAISE SEVENTY NINE ONLY) PER BAG PER MONTH.

3. The month for the purpose will mean a period of 30 days and the total storage charges calculated on per week basis will not exceed the total charges payable per bag of 50 kg. for the full month. After the first week in storage, the period will be reckoned as a calendar month.
