Sub: Scheme for construction of godowns for FCI - Storage Requirement through Private Entrepreneur - 2008 - Modified PEG-08 Scheme.

Sir,

Please take reference of Ministry of CAF &PD letter No.20-3/2007-FC-II dated 25-1-2010 on the above cited subject for necessary action in view of modifications in the PEG - 2008 Scheme (copy enclosed for ready reference) which has been already circulated by FCI, Headquarters to all ED (Zone)/GM(Regions) FCI vide letter No.E.3(28)/PEG-2008/PR/STG.IV dated 29.1.2010.

In this regard, it has been decided to categorize technically qualified tender received in the tender enquiries, floated earlier for 5 year guarantee under this scheme in following categories:-

Where rates received are less than Rs2.08 per 50 kg. bag per month along with preservation and security etc. (after reducing 15% of supervision charges from Rs.4.78 per quintal per month or from Rs.2.39 per 50 kg. bag per month)

Those technically qualified offers which fall under above mentioned category and the party is willing to accept the revised directions of Board Of Directors (BOI) given regarding yearly escalation during its meeting dated 27.1.2010(Annexure I) them these offers may be accepted otherwise offers should be rejected.

## Where the rates received are more than Rs.2.08 per 50 kg. bag per month with preservation security etc.

If the party is willing to accept the revised directions of BOD regarding year escalations during the meeting on 27.1.2010 (Annexure I), these offers should be evaluated as per prescribed guidelines of the modified scheme by the State Leve-Committee(SLC). SLC may reject all or any of the offers and send all or any offers to FCI Headquarters for consideration of High Level Committee(HLC) along with the recommendation of SLC. Where the party is not willing to accept the revise directions of BOD regarding the escalations, such offers should be rejected.





(C) Where the Private Party has offered only the Godown space and the preservation & security etc. services are to be carried out by the implementing/nodal agency i.e. CWC/SWC or any other agency prescribed as per Scheme.

In such cases the fixation of component 'B' is being finalized by FC' Headquarters. After the fixation of this component, such offers may be evaluated and if the rates received are within the indexed CWC rates of Rs 4.78 per quintal per month or Rs 2.39 per 50 kg bag per month including the component 'B' and the 15% supervision charges, such offers may be accepted. Where the rates received are higher than these rates, such offers may be evaluated as per prescribed guidelines of the modified scheme by the SLC. SLC may reject all or any of the offers and send all or any offers to FCI Headquarters for consideration of HLC along with the recommendation of SLC.

It is further clarified that as these bids have been received against 5 years guarantee offer so such godowns will be hired on the guarantee of 5 years only. Moreover as the BOD has decided that the clause of utilization of these godowns at higher than the rated capacity should be removed from the agreement so the agreement should be signed with these parties only after removing the clause from the agreement which authorized FCI to use such godowns on higher than the rated capacity.

It has been also decided that all ED (Zone) FCI will immediately revise the tender document to incorporate the revised guidelines issued by Govt. of India vide it's above mentioned letter dt.25.1.2010 and the Board decision dt.27.1.2010 (Annexure-I to this letter).

It is requested to ensure immediate re-tendering for the left over capacities under the revised PEG – 2008 Scheme and take all measures to implement the scheme in a time bound manner.

This issues with the approval of CMD.
