**Sub-** Clarification on 8% supervision charges on H&T bills and 15% Supervision charges on storage rent reg.

Sir,

Various references have been received from many regions, latest from FCI RO, Kerla, regarding Supervision charges in PEG godowns. In this regard, it is to clarify that there are two different types PEG godowns- one, where SWC and CWCs are Nodal Agencies and the godowns have been constructed by Private investors and, the second is where CWC/SWCs have constructed godown at their own land. The payment of Supervision charges in both the cases are clarified as under:

1. Payment of Supervision charges upto 15% of rent being paid to CWC/SWCs in case of godowns constructed by Pvt investors.

The Decision taken in  $48^{th}$  HLC Meeting held on 9.11.2016, reiterated in the  $51^{st}$ HLC dated:17.4.2018 is relevant which states that; "the present Supervision charges upto 15% of rent being paid to CWC/SWCs are sufficient to meet the expenses on existing manpower deployed in PEG godowns by CWC/SWCs for supervision work, so there is no need to pay additional 8% Supervision charges on H&T bills to CWC/SWCs."

2. Payment of 8% supervision charges on H&T bills to CWC/SWCs where godowns are constructed by CWC/SWCs on their own land.

The decision taken in 43<sup>rd</sup> HLC dt. 25.05.2015 is relevant which states that; "8% Supervision charges on H&T bills may be paid in case of CWC/SWCs PEG godowns constructed on their own land where 15% Supervision charges are not being paid."

This issues with the approval of Competent Authority.
