**Subject:** Clarification on Supervision Charges paid to Nodal Agency...reg.

Sir,


Reference was received from RO, Punjab seeking clarification, whether 15% Supervision Charges paid to Nodal Agency is to be paid on the composite of rent which includes 'godown rent' + 'Service tax/GST' or only on the godown rent portion in case of 7 year PEG guarantee godown.

In this regard, the matter has been examined in consultation with Legal and Finance Division, FCI, Hqrs who have opined that out of composite rent paid to the private parties the tax part is remitted to the Taxation Authorities. It is observed that the word, "Payment made by Nodal Agency to Private party" as used in part [A] of clause no. 14 of PEG Scheme-08 actually means the amount which is meant to be retained by the party for its own use, discharge of its personal/ commercial obligations etc. The amount passed on to the Private Party for its further deposition with the Taxation Authority does not fall under the scope of Part [A] of clause no.14 of PEG Scheme-2008. Hence, 15% Supervision charges is not payable to the Nodal Agency on Tax Component as the same is not admissible.

In this regard, all Zones/ Regions are requested to take immediate steps to recover the aforesaid non admissible payment made to the Agencies, if any, and to stop such further remittances.

This issues with the approval of CMD.
