With reference to the above subject, it is intimated that this Department had taken up the matter for allocation of Rs.214 crore for construction of godowns as part of special package for Bihar on the basis of information received from FCI and CWC. (A copy of this Ministry Office Memorandum of even number dated 23rd June, 2015 addressed to Secretary, Department of Expenditure, Ministry of Finance is enclosed for ready reference).


